4.1 Description of first aid measures.

Inhalation.

SECTION 5: FIREFIGHTING MEASURES.

5.1 Extinguishing media.

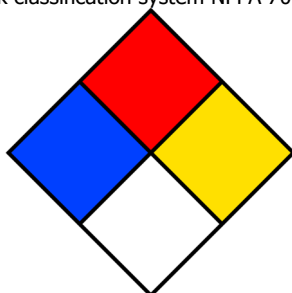
