## 4. FIRST AID MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

Clean up spills immediately observing the precautions in Section 8 of this SDS. Dike and contain the spill with inert material (sand, earth, etc.) and transfer liquid and solid diking material to separate containers for disposal. Keep the spill out of all sewers and open bodies of water.

## 7. HANDLING AND STORAGE

Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing/PPE immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Follow the instructions in section 8 of this SDS for protective equipment.

## 12. ECOLOGICAL INFORMATION

This chemical and its transformation products demonstrate the properties and characteristics associated with chemicals detected in ground water. The use of this chemical in areas where soils are permeable, particularly where the water table is shallow, may result in ground-water contamination.

This chemical can contaminate surface water through spray drift.

This chemical can contaminate surface water through spray drift.

This product may impact surface water quality due to runoff of rain water. This is especially true for poorly draining soils and soils with shallow groundwater. This product is classified as having a high potential for reaching surface water via runoff for several weeks after application. A level well-maintained vegetative buffer strip between areas to which this product is applied and surface water features such as ponds, streams and springs will reduce the potential loading of cloransulam methyl from runoff water and sediment. Runoff of this product will be reduced by avoiding applications when rainfall or irrigation is expected to occur within 48 hours.
