Select a spray volume appropriate for the density of foliage. For best results with airblast/tower sprayers apply in 50-100 gallons water per acre.</p> <p>For Best Results: Make two post-bloom applications spaced 7-10 days apart, with the first application made as soon as managed bees are removed from the field. Use with a penetrating adjuvant.</p> <p>Resistance Management: Do not apply VERDEPRYN 100 SL INSECTICIDE or other Group 28 insecticide more than 3 times within a single generation of insect pest(s) on a crop.</p> <p>Restrictions: This product has been determined to have a short residual toxicity (RT25) time. Foliar application of this product is prohibited from onset of flowering until flowering is complete unless: The rate is limited to 0.054 lbs. a.i./A and the application is made in the time period between 2 hours prior to sunset and 8 hours prior to sunrise.</p> <p>Make no more than 3 applications per year. Minimal interval between treatments is 5 days.</p> <p>Do not apply more than 33 fl. oz. VERDEPRYN 100 SL INSECTICIDE per acre per year (0.22 lb. a.i./acre/year).</p> <p>In New York State, do not apply more than 27 fl. oz. per acre per year (0.18 lb. a.i./acre/year).</p> <p>Pre-Harvest Interval (PHI) – 1 day</p>
